From the Pastor

Not often but occasionally I think about retirement - when it might happen and what it might look like (Lord willing, not any time soon). And every time I think about retirement, I am reminded of Billy Graham's answer when asked why he continued preaching and crusading, even into his eighties and beyond. His answer was – and if this is not precisely what he said, it is very close – "I never have found the word 'retirement' in the Bible." I have often reflected on that answer. The obvious question is – "Was Dr. Graham right or was he wrong?"

Well, let's start with sheer linguistics. A strict and mere Biblicist answer is that Dr. Graham was correct. To the best of my knowledge, one will not find the word "retirement" in the Bible. And to my limited knowledge (key word "limited"), there is no Hebrew or Greek counterpart for our English word retirement. But God does not call us to be mere Biblicists who say that if we cannot find one catch-all proof text then a doctrine cannot be biblical. The word Trinity is not found in the Bible; yet as we look at numerous biblical concepts and verses, we cannot escape the fact that the God of the Bible is triune in essence.

Well and good; the Trinity is biblical. But what about retirement? Well, there are a couple of passages which lend some support to the concept of retirement. In Numbers 4:1-49 we are told that the Levites, including the clans of Kohath, Gershon, and Merari, were called into service at age 30 and were formally released from their official duty at age fifty. Later Numbers 8:25-6 summarizes, "And from the age of fifty years they shall withdraw from the duty of the service and serve no more. They minister to their brothers in the tent of meeting by keeping guard, but they shall do no service (ESV)." Who knows all the reasons why the Lord determined to restrict the tabernacle service of the Levites to men between thirty and fifty, but the Numbers 4 passage clearly implies that the "heavy lifting" associated with their tabernacle service was a factor. That being the case, we see that the Bible does recognize some limited concept of retirement. Further, my guess is that this statute in the law had at least something to do with the reality that in a fallen world the older we get the less we are able to do all that we once could. That is one thing we should love about the Bible – it is so realistic.

And if the Bible does recognize some concept of retirement, then there is a reminder that there may come a day when we are no longer able to perform quite the way we once could. Various professions recognize that and have retirement rules to effect it. Yet to say that we may find a retirement concept in the Bible is far from saying we may reach a certain age and adopt a "retirement mentality." Joel Beeke (or perhaps it was Mark Jones; the book was co-authored) tells of sitting next to a newly retired evangelical minister on a plane. In the course of conversation, the minister stated: "The way I figure is that I gave my entire life to the Lord and His church, so now I'm going to live the rest of it for me" (*A Puritan Theology: Doctrine for Life* by Joel R. Beeke & Mark Jones, 846). I think that is precisely the sinful retirement mentality Dr. Graham had in mind when he responded to the question about his prolonged ministry.

But if the Bible does recognize some conception of retirement and yet cautions against adopting a "retirement mentality," then what should be our attitude about retirement and how should that affect our work in the world and our service to the Lord? First (and quickly), God has created us to work and we should do our best to be as productive as we can be as long as possible (Gen. 2:15; Exod. 20:9). That does not necessarily mean that we should be paid for our services, if we are not in financial need. It simply means we should strive to be productive, to be doing things to help others in the world. The same principle holds true in the church. We should be doing what we can as long as we can, while at the same time passing on our knowledge and experience to others who will serve after we are no longer able.

Age affects some differently than others as the example of Caleb shows us. He stated that even at 85 he was as strong at the day Moses called him into service and therefore was more than capable of taking on the fearful Anakim with their fortified cities (Josh. 14:10-2). Moses was eighty years old and Aaron eighty-three when they spoke to Pharaoh (Exod. 7:7). In Israel elders were elders in part because they were older and thus considered wiser. Even when elders are not able to serve as fully as they once could they should provide counsel where needed and we should gladly receive it (Lev. 19:32). Furthermore, Paul counsels the

older women that they should teach sound doctrine to the younger women. Flowing out of that sound doctrine and godly examples these older widows were to train up the younger women to fulfill their God-given roles as wives and mothers (Titus 2:3-5). And what if an elderly lady is too old to teach? She can at least pray. Paul counsels Timothy with regard to the blessing older widows can be to the church – "She who is truly a widow, left all alone, has set her hope on God and continues in supplications and prayers night and day, but she who is self-indulgent is dead even while she lives" (1 Tim. 5:5-6 ESV). The self-indulgent widow is no different than the retired evangelical minister on Beeke's plane. God calls us to do all we can for him as long as we can, as best we can. We may retire in a formal sense, but we should never retire in a spiritual and practical sense. As long as the Lord gives us breath, we are to seek to serve him. That is a biblical retirement mentality. In fact, that is retirement theology.

- LORD'S SUPPER APRIL 3: We will be observing the Lord's Supper next Sunday. In order to receive the optimal blessing from the Lord's Supper and to avoid condemnation, it is wise to prepare accordingly. One helpful way to prepare is to meditate upon Westminster Larger Catechism question #171. The question is: How are they who receive the sacrament of the Lord's Supper to prepare themselves before they come to it? The answer is: They who receive the sacrament of the Lord's Supper are, before they come, to prepare themselves for it, by examining themselves of their being in Christ, of their sins and wants; of the truth and measure of their knowledge, faith, repentance, love to God and the brothers, charity to all men, forgiving those who have done them wrong; of their desires after Christ, and of their new obedience; and by renewing the exercise of these graces, by serious meditation, and fervent prayer.
- LORD'S DAY EVENING FELLOWSHIP: There is no better way to close out the Lord's Day than together in fellowship with the Lord and his people. Everyone is invited to the manse at 6:00 p.m. for our Lord's Day Evening Fellowship, which includes include a discussion-oriented study of the Westminster Confession of Faith, a season of prayer, and singing (a Psalm and a hymn).
