From the Pastor:

There are all kinds of things people assume are taught in the Bible which are not really so. That is especially true when it comes to the subject of eschatology or the "doctrine of the last things." One specific example of assumed yet unsubstantiated teaching is the so-called "secret rapture." Another is a common misconception about the so-called "last days." It is commonly assumed that the phrase "last days" refers to the very last sliver of history immediately prior to Jesus' return (for some of course that would be the time just before the so-called "secret rapture"). But does the phrase "last days" actually refer to the very end of history? Let's see what the Bible actually says.

And let's start with Acts 2:17. It is Peter's great Pentecost sermon and he proclaims, "And in the last days it shall be, God declares, that I will pour out my Spirit on all flesh, and your sons and your daughters shall

all dream dreams" (Acts 2:17 ESV).

prophesy, and your young men shall see visions, and your old men shall dream dreams" (Acts 2:17 ESV). The noteworthy thing here is that Peter is not predicting some phenomena yet to come but rather quoting the prophet Joel. Peter is in effect saying that what Joel prophesied long ago is being fulfilled *now* "in the last days." In other words, the events of Pentecost were a sign that the "last days" had begun.

Now let's turn to 2 Timothy and the book that is probably the apostle Paul's last before his martyrdom. He is exhorting his protegee Timothy to remain faithful in preaching the gospel, as well as warning Timothy that he will need to be on guard against false teachers sliding into the Ephesian church. In that context come those familiar words, "But understand this, that in the last days there will come times of difficulty. For people will be lovers of self, lovers of money, proud, arrogant, abusive, disobedient to their parents, ... lovers of pleasure rather than lovers of God, having the appearance of godliness, but denying its power. Avoid such people" (2 Tim. 3:1-5). People "naturally" assume that Paul is warning us about godless people in our day; yet that would have made no sense to the one who read the letter first, namely Timothy. That, of course, does not mean there are not such people and teachers in our day. It is to say that Paul was first and foremost addressing a problem in his own day, which problem was a sign they were living in the "last days," even in the *first* century.

And then there is that familiar opening to the book of Hebrews, where we read in chapter 1 verse 2, "But in these last days he has spoken to us by his Son, whom he appointed the heir of all things, through whom also he created the world" (Heb. 1:2 ESV). Does this mean that because someone announces that he or she has a new "word from the Lord" that we must be living in the "last days"? The Hebrew Christians to whom this letter was addressed certainly would not have understood these words this way. The writer of Hebrews, whoever he was, almost certainly has in mind Jesus' upper room promise to his disciples that after his death and resurrection the Holy Spirit would bring to their minds the specifics of Jesus' life, teaching, death and resurrection, and that it was their (the apostles) duty not only to preach these things but also to put them into writing (John 14:26; 15:26; 16:13-5).

There is also James 5:3 in which the brother, or more technically the "half-brother," of our Lord rebukes his wealthy and self-centered readers as follows, "Your gold and silver have corroded, and their corrosion will be evidence against you and will eat your flesh like fire. You have laid up treasure in the last days." James is not of course denying that there will be wealthy persons who live for themselves at a later time or immediately before Jesus returns. However, he is clearly dealing with a problem which already existed in his day. He says such persons "have laid up treasure (it has already begun to happen) in the last days." Clearly James thought he was already living in the "last days," even in the first century. Furthermore, he was writing under the inspiration of the Holy Spirit.

Finally, let's go back to the apostle Peter and his second epistle. Most likely, he writes somewhere around 67-8 AD and shortly before his martyrdom. Among other things, Peter's desire is to warn his readers about false teachers who will twist the gospel message for personal gain. He writes, "You should remember the predictions of the holy prophets and the commandment of the Lord and Savior through your apostles, knowing this first of all, that scoffers will come in the last days with scoffing, following their own sinful desires" (2 Pet. 3:2-3). Here again, Peter's immediate concern isn't skeptics who would later infiltrate the church. As he prepares to die, he is primarily concerned with scoffers who are already scoffing in Peter's day. The fact they such persons were already causing problems in the church was evidence that Peter and his readers were already living in the *last days*. The application for us is that just as Peter's readers needed to be mindful of such scoffing, so do we.

What then does the phrase "last days" actually refer? The cumulative effect of the above passages seems to be that the period prior to Jesus' coming (BC) was the "former days" and that "last days" refers to the whole period of time between Jesus' first and second comings. According to the above definition, we are, even now, living in the "last days." However, so were the apostles, and so will those be who are alive when Jesus returns. One practical lesson we can take from this little exercise is simply that we always need to make sure that our understanding of biblical teaching is informed by scripture, as opposed to the latest best-seller in the Christian bookstore or a favorite television preacher. How does one make sure his or her understanding is biblical? Two things. First, make sure you are sitting under good biblical teaching in a faithful evangelical church; not just every now and then, but week in and week out. Second, don't take either your pastor or favorite teacher's word as your ultimate authority. Be a Berean; go home and search the scripture for yourself to "see if these things be so" (Acts 17:11).
