From the Pastor:

In our worship services we are proceeding through a study of the law of God as it is revealed in Exodus 20-24. More specifically, we are presently studying the Decalogue or Ten Commandments which we find in Exodus 20:3-17. At the same time, we are reading through Psalm 119 which is a sort of "love letter" to the Lord thanking him for his "law." Admittedly, the term "law" in Psalm 119 may have a broader meaning than the law given to Moses; yet it certainly does not mean less than that. The point is that the Psalmist *loves* God's law and wants the believer to cultivate that same type of love for the law of God. But why? Why should we love God's law? What good ends did God intend for it? For the answer to that question, we turn to the three-fold use of the law which was crystalized by the great John Calvin. Calvin saw that God had at least three primary purposes in mind when he gave his law to Moses. Let's consider those.

The first is the so-called "pedagogical use" of the law. The idea here is that the law functions as a school teacher whose end it is to lead us to Christ. In this sense the law reveals the holy and perfect will of God. It acts as a mirror of sorts reflecting to us the perfect righteousness of God and thus reveals our own sinfulness. The great St. Augustine put it this way, "The law bids us, as we try to fulfill its requirements, and become wearied in our weakness under it, to know how to ask the help of grace" ("The Threefold Use of the Law" by Nathan W. Bingham). In this sense the law is of special use to unbelievers. Westminster Shorter Catechism question 96 asks, "What particular use is there of the moral law to unregenerate (unbelieving) men?" It answers, "The moral law is of use to unregenerate men, to awaken their conscience to flee from the wrath to come, and to drive them to Christ; or upon their continuance in the estate and way of sin, to leave them inexcusable, and under the curse thereof." To put it more simply, the law shows us our sin, the danger of God's wrath, and the love of God in Christ, which are all intended to move us to flee to Christ for salvation.

That brings us to the second use commonly called the "civil use." This use of the law is common for all people, believer and unbeliever alike. The idea here is that God gives his law in order to restrain evil in the world. I am driving down the road and I spot a state trooper up ahead by the roadside and I immediately check my speed to make sure I am not violating the law. Why? Because if I am breaking the law, I am subject to punishment by the civil magistrate. To be crass about it, one reason I don't speed is that I don't like paying speeding tickets; they can be quite costly. Or this. Let's say you walk in a store and you see a suspicious looking character with what looks to be a gun in a holster of sorts near his waistline. You are a bit concerned but less so when you see the security guard or policeman on duty there a few aisles down. There are laws against armed robbery and murder on the books (6th and 7th commandments) and people who enforce those laws (Rom. 13:3-4), and you are quite thankful that is the case. While this use of the law applies to all sorts of people, believers are especially benefited, as it makes it easier for us to worship God according to his Word and make disciples in obedience to his command.

That brings us to the third and final use, sometimes referred to as the moral or normative use. In this sense the law acts as a sort of guide in which the Lord reveals to believers how they are to live for his glory. Question #97 of the Westminster Larger Catechism asks, "What special use is there of the moral law to the regenerate (believers)? It answers that while the law no longer hovers over us ready to crush us, it is "of special use" to believers to "provoke them to more thankfulness, and to express the same in their greater care to conform themselves thereunto as the rule of their obedience." To put is another way, the moral law reveals to us those good works the Lord has planned for us to do (Eph. 2:10). Believers may think of many good works they feel compelled to performed; however, our first and foremost "good work" is keeping God's commandments. When Jesus commissioned his apostles to make disciples, he instructed them to teach them all he *commanded* (Matt. 28:20). That certainly included more than the Ten Commandments but surely not less. After all, Jesus also said, "If you love me, you will keep my commandments" (Jn. 14:15)
